In our effort to successfully recruit a qualified and diverse slate of candidates, we have developed a comprehensive selection process. Though times between steps may vary, the entire process will take approximately two - three months. The process includes the following:

STEP 1. The Nominating Committee will review your application against the skills, experience and leadership qualities currently required by Harvest Project.

STEP 2. Short listed candidates will be contacted by the Board Chair and/or the Nomination Committee for a telephone conversation to determine mutual fit.

STEP 3. *Short listed candidates will receive a tour of Harvest Project, with the opportunity to meet existing Board Members and learn more about the organization.

STEP 4. Candidates selected to proceed will attend a Board meeting as a guest.

STEP 5. Names of successful candidates will then be submitted for election at a future Board meeting.

STEP 6. New board members will be provided with an orientation, where they will have the opportunity to experience the different volunteer activities integral to Harvest Project's work.

*Please note that Harvest Project requires successful completion of two references as well as a criminal background and vulnerable persons check prior to finalizing all applications for Board positions.

Board structure and function

Harvest Project is a faith-based organization, led by up to 15 Directors. The role of the Board is to govern the organization and oversee its activities. It focuses on the strategic and overall activities of The Harvest Project, not the day-to-day operations. Operational activities are the responsibility of staff and Executive Director, who report to the Board of Directors.

Roles and Responsibilities of the Board of Directors:

Harvest Project welcomes applications from diverse applicants who wish to make a meaningful impact on their community through serving on a board.

Reporting to the Chair of the Board, Board members work within an integrated team to achieve the mission and mandate of Harvest Project. They provide leadership, stewardship, fiduciary and financial oversight, and ensure and support appropriate management of the organization. Our Directors serve as ambassadors and advocates for Harvest Project, reflecting our values, and champion Harvest Project to the larger community. They leverage connections, networks, and resources to develop collective action to fully achieve our mission. Our Directors also make a personal financial contribution to Harvest Project on an annual basis.

The Board's commitments to the individual directors:

- You have the commitment of the other directors everyone takes their responsibility seriously.
- Effective use of time time spent in meetings is used wisely, with meetings usually scheduled for two hours.
- Access to information relevant to Board decisions will be provided in advance whenever possible.
- Training and support a board information and comprehensive orientation package will be provided.
